## Privacy Policy

*Last Updated: September 9th, 2020*

### 1. General

The Covid Detection Foundation d.b.a. Virufy (“Virufy”, “we”, “us” or “our”), a California nonprofit corporation, respects your privacy and is committed to processing your personal information in accordance with the law. This Privacy Policy (hereinafter the “Policy” or “Privacy Policy”) sets out how we use, store, disclose and process personal information that you provide to us when you participate in our research survey for the development of the app for smartphone and/or other device-based COVID-19 early detection (the “App”), or that we obtain through or in connection with the use of our website ([www.virufy.org](http://www.virufy.org)) (“Website”), or when you otherwise contact us and/or we collect your personal information.

For the purposes of the Brazilian General Personal Data Protection Law (the “LGPD”), Virufy is the “data controller” of, and responsible for, your personal information collected in accordance with this Privacy Policy.

### 2. What is “personal information”?

The term “personal information” as used in this Policy shall mean any information (including “personal data”, “health data” and “biometric information” as those terms may be defined) that actually enables, or is capable of enabling us to identify you, directly or indirectly, by reference to an identifier such as your name, age, gender identity, postal address, email address, location data, online identifier or one or more factors specific to you.

We collect “biometric information” and health data, such as COVID-19 symptoms and related medical symptoms and respiratory conditions. Under the LGPD, “biometric data” and information about your health is referred to as “sensitive personal data”, and is deemed to be more sensitive than general personal information and requires more protection.

### 3. What data do we collect?

We may collect and process the following personal information about you:

- **Information you provide to us** – You provide us with your personal information in many ways, including by participating in the development of the App and assisting us with promoting the research of coughs through AI algorithms. Such personal information may include: your email address, phone number, age group, gender identity, location, smoking status, relevant medical conditions, relevant respiratory conditions, COVID-19 symptoms, COVID-19 testing results, the timeframe of your COVID-19 tests taken and onset of symptoms, calibration recording (e.g. speech), and cough sample recording. You may also provide us with your personal information when you fill in forms, request information, submit applications for job and volunteer opportunities posted on the Website or correspond with us by post, phone, email or otherwise. Such personal information may include: name, address, email address, telephone number, resume and cover letter, professional history, academic history/status, answers to questions about suitability for a position, interview notes related to job fitness and experience, professional references, professional and personal competencies, extracurricular activities and your correspondence with us.
- **Information we collect about you** - When you visit our Website we may collect information about your computer or device, including your IP address, location, operating system, browser information, information about your visit, your browsing history, and how you use our Website. These types of data are collected by cookies and related technologies, including Google Analytics, JotForm, Cookiebot, and Hotjar. When you first access our Website from certain jurisdictions, you will receive a message advising you that cookies and similar technologies are in use. By clicking “accept cookies”, you signify that you understand and agree to the use of these technologies, as described in our Cookie Policy. For more information about our practices in this area, please see our Cookie Policy.

### 4. How do we use your data?

We will only process personal information in accordance with the applicable Brazilian law.

We may collect and process personal information and biometric and health information (deemed to be sensitive personal data under the LGPD) only where you have given your explicit consent via the Explicit Consent to Collect Personal Information and Participate in Research Form (such consent may be withdrawn at any time):

- To conduct research and develop the App for smartphones and other devices that use artificial intelligence to diagnose COVID-19;

- To train machine learning models to analyze your audio recordings in order to better determine signs of COVID-19;
- To conduct research and develop future applications that use artificial intelligence to diagnose and/or be used for other viruses and medical conditions;
- To train machine learning models to analyze your audio recordings in order to better determine early signs of and/or be used for other viruses and medical conditions; and
- To conduct demographic analysis of COVID cases and/or other medical research beneficial for the medical community.

We will process non-biometric personal information for the following purposes as necessary, based in the legal bases as legitimate interests, regular exercise of rights, legal obligation, execution of contract, or where you have given your informed consent to such processing if required by applicable law (such consent can be withdrawn at any time):

- **Where you participate in our research projects** – so we can contact you by email and/or phone in relation to the cough sample you have donated, and to remind you to donate subsequent samples at regular intervals and/or to follow up on testing;
- **Where you are applying for a job or volunteer vacancy with us** – to assess your qualifications with respect to available positions within Virufy, to potentially review references and facilitate background screening and to decide whether to enter into a volunteer or employment relationship with you;
- To monitor quality control and ensure compliance with any and all applicable laws, regulations, codes and ordinances, for example, in response to a request from a court or regulatory body, where such request is made in accordance with the law;
- To resolve any disputes;
- To administer our internal business administration and operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes; and
- To develop and improve our Website and App, for example, by reviewing visits to the Website and various subpages.

Subject to applicable laws, we may process your personal information in order to protect your vital interests or the vital interests of another person.

## 5. Data processing in the United States

If you are visiting our Website, and/or assisting with our research, or otherwise providing personal information to us from outside the U.S., be aware that your personal information may be transferred to, stored, and processed by us outside of the jurisdiction within which you are

based. For more information about how we transfer your personal information, please refer to Section 9 of this Privacy Policy.

## **6. Where is your data stored?**

We use JotForm for research study data collection. JotForm stores the data in a secure application with restricted access and controls. Your data will be stored with JotForm until it is downloaded by us. We will store the data in a database with restricted access. If you would like more information about how JotForm stores your data, please reference JotForm's Privacy Policy at <https://www.jotform.com/privacy/>.

Information supplied for volunteer and employment applications will be stored in a secured cloud data server only accessible by Virufy recruitment staff.

## **7. For how long is your data stored?**

We will store your personal data in a form that permits us to identify you for 6 (six) months for the purposes for which the personal information is processed. For the avoidance of doubt, biometric and health data, such as cough recordings, may be retained long term for future research studies into viruses and other medical conditions, since the data will no longer be identifiable after anonymization.

We will store personal information associated with job and volunteer applications and email communications, in a form that permits us to identify you, for no longer than is necessary for the purpose for which the personal information is processed, according to the applicable laws. We store your personal information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements and rights. Otherwise, we will seek to delete your personal information within a reasonable timeframe upon request accordingly with your rights.

## **8. How is this data shared?**

Broadly, your data comprises your consent from the Explicit Consent to Collect Personal Information and Participate in Research Form and the personal information (including the health and biometric information) provided by you. Access to your biometric and health data is restricted to our research team in the first instance and may also be shared with other researchers. We may distribute your personal information to partners for future research studies and you hereby explicitly consent to this. We may also publish or present the results of this study containing your anonymous information. Your personal information may be released if required by the law and competent authorities.

We may also share your anonymized personal information in the following ways:

- As an open access dataset for usage by researchers globally to accelerate development of the solution.

We may also share your non-anonymized personal information in the following ways:

- With another legal entity, on a temporary or permanent basis, for the purposes of a joint venture, collaboration, financing, sale, merger, reorganization, change of legal form, dissolution or similar event. In the case of a merger or sale, your personal information may be permanently transferred to a successor company. If a change happens to our business, then the new owners may use your personal information in the same way as set out in this Statement.
- Where needed to enforce our rights, protect our property or protect the rights, or safety of Virufy and others, or to support external auditing, compliance and corporate governance functions.
- Public authorities where we are required by law to do so.
- If required, in order to receive legal advice.

## **9. International transfers of personal information**

Where personal information relating to individuals based in the Brazillian territory is shared with a third party located in another country that has not received an adequacy decision by the National Authority of Data Protection (“ANPD”) , we rely upon appropriate safeguards, such as the European Commission-approved Standard Contractual Clauses, as the ANPD doesn't regulate this topic. ## **10. Managing and deleting your data**

You can manage or delete your data by contacting us with your verification number at [study@virufy.org](mailto:study@virufy.org), with the subject “Data Privacy Concern: [Verification Number].” The verification number is the special number we provided you on your successful completion of the JotForm survey.

# 11. Privacy rights

In certain circumstances, you may have the following rights in relation to your personal information:

- **Request access to your personal information.** You may have the right to request access to any personal information we hold about you as well as related data, including the purposes for processing the personal information, the recipients or categories of recipients with whom the personal information has been shared, where possible, the period for which the personal information will be stored, the source of the personal information, and the existence of any automated decision making.
- **Request correction of your personal information.** You may have the right to obtain without undue delay the rectification of any inaccurate or outdated personal information we hold about you.
- **Request erasure of your personal information.** You may have the right to request that personal information that was given with your consent is deleted.
- **Request restriction of processing your personal information.** You may have the right to prevent or restrict processing of your personal information.
- **Request transfer of your personal information.** You may have the right to request transfer of your personal information directly to a third party where this is technically feasible.
- **Right to object.** You may have the right to object to the processing of your personal information when you have legitimate reasons to do so.
- **Right to withdraw consent.** Where processing is based on consent, you may have the right to withdraw such consent.
- **Request the anonymization, blockage or elimination of unnecessary, excessive and non-compliant processed data.** You may have the right to have excessive, unnecessary or non-compliant processed data anonymized or excluded accordingly with the principle of necessity.
- **Request confirmation of your personal information.** You may have the right to confirm if we process your personal information.
- **Right to obtaining information about the public or private entities with which Virufy has shared your data**

We aim to respond to requests made by you within one month, but may extend that period by two further months where necessary. However for requests based on access and confirmation of your personal information, we will respond within 15 (fifteen) days from the date of your request.

If you request deletion of essential information, such as cough recordings, for the management of your account with Virufy, this will result in the termination of your registration and participation of the research.

Virufy hereby declares to make every effort to fulfill such requests in the shortest possible time frame. However, even in case of exclusion or deletion requests, the minimum storage period for information of users of Internet Applications, determined by Brazilian legislation, will be respected.

Where you believe that we have not complied with our obligation under this Privacy Statement or Brazilian data protection law, you have the right to make a complaint to the National Authority of Data Protection or any other legal authority.

## **12. Do not track signals**

We do not respond to web browser “do not track” signals. As such, your navigation of our Website may be tracked as part of the gathering of quantitative user information. If you arrive at our Website by way of a link from a third party site that does respond to “do not track” requests, the recognition of any “do not track” request you have initiated will end as soon as you reach our Website.

## **13. Amendments to this Privacy Policy**

We may amend this Policy at any time. Any changes we may make will be posted on this page, so please check back frequently. The most recent version of this Policy is reflected by the version date located at the top of this Policy.
